Most offices have more than one of the same insurance company with different addresses. Although the claims go to different addresses, the payment could come back all on the same check.

From the IC—Insurance Companies table, on the top right column is the Insurance Group field. By clicking on the ellipsis, you will be able to select an insurance group. If your office has not created insurance groups, it is a very simple process. Begin by double clicking on Data Entry - Click on the # symbol to create an ID - Enter a Description, e.g. Aetna Group - click on Select to take the information back to the Insurance Company screen.
